

*Scholars of antiquity – unlike their colleagues working on later periods – largely employ evidence provided by highly stylized literary texts. This is, of course, due to the scantiness of documentary material. Whereas even medieval historians can draw on archives in continuous use that provide them with original charters and deeds going back down to the 7th c. AD, classicists only possess the odd document transmitted in manuscripts or extant on papyrus, stone or metal, despite the ravages of time.*

*The study of ancient documents mostly takes place within the framework of the so-called auxiliary sciences of history, meaning extant papyri and inscriptions are in many cases much more thoroughly scrutinized than the many documents that made it through the bottleneck of transmission by being included in a larger dossier which was then continuously copied thanks to the faithful work of scribes. These latter documents are mostly the object of study by legal historians or classicists with an interest in law, as many of them pertain to the context of imperial legislation.*

*It is the aim of this workshop to bring together papyrologists, epigraphers and scholars working on documents transmitted in manuscripts, as the evidence they investigate is notably similar; often the only difference is the way of transmission. This workshop will take place as part of the ERC Starting Grant project “ACO”, which is dedicated to the Acts of the Ecumenical Councils, the arguably most prolific source for late antique documentary evidence.*

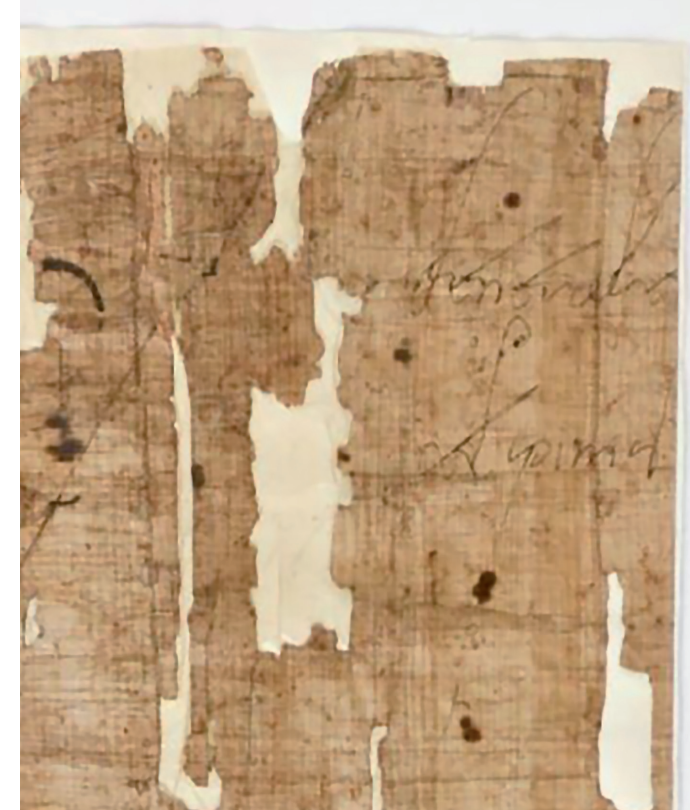
